Three Gaits Mission

Three Gaits, Inc. is a non-profit, tax-exempt organization whose mission is to provide a safe and effective therapeutic horsemanship program for children, youth, and adults with disabilities and special needs.

Three Gaits History

Three Gaits was started in 1983 by Gail Brown and Lorrie Renker, with two horses and eight riders. The guiding vision was a love for horses and an interest in providing equine-assisted activities for individuals with disabilities in Dane County. The name Three Gaits refers to three movements of a horse -- walk, trot and canter -- with the implication that no limits are imposed on someone's desire to learn to ride.

Community response to the program was enthusiastic, and by 1986, Three Gaits gained sufficient support to obtain a mortgage for our 20-acre farm located on Highway 138 between Stoughton and Oregon. Significant improvements to the property have been made over the years, and currently the facility features indoor and outdoor riding arenas, a 26-stall pole barn, an office/classroom building and a farmhouse for the equine caretaker.

Since 2002, Three Gaits has been a Premier Accredited Center with PATH International, Professional Association of Therapeutic Horsemanship International (formerly NARHA). PATH International is responsible for establishing safety standards and quality control. PATH International also certifies our riding instructors, meaning they have passed examinations and evaluations of their teaching and riding skills. In addition, instructors are First Aid and CPR certified and they participate in a minimum of twenty hours of continuing education annually.

The steady growth of Three Gaits therapeutic riding program and the continued demand for services show that consumers and their families, as well as service providers and other professionals, feel that the program has a definite positive impact on participants' lives. Today, approximately fifteen program horses, a large number of volunteers and a limited, yet very dedicated staff provide more than 250 children, youth and adults each year the opportunity to extend therapy, special education and interpersonal skill development into the horsemanship experience. The total number of equine assisted activities (units of service) provided in 2015 will be comparable with the over 3,000 activities offered in 2014.

It is the policy of Three Gaits, Inc. to promote equal service and employment opportunities for all employees, clients, board members and applicants to the agency. Equal service and employment opportunity means the treatment of those categories of people mentioned above without regard to their age, race, sex, creed or religion, marital status, sexual orientation, national origin, color, disability, ancestry, or political affiliation.



Who we serve and what we do

In 2015, Three Gaits offered over 2,800 equine assisted activities (units of service) to approximately 230 individuals taking part in 315 session spots (some individuals participate in multiple sessions). This translates to approximately 105 people each week during the 36 weeks of regular program activities, plus an additional 50 children each year in field trips. People served by Three Gaits have been diagnosed with disorders such as autism, Down syndrome, learning disabilities, spina bifida, muscular dystrophy, cerebral palsy, brain injury, as well as numerous other conditions causing disability and special needs. Most participants have both intellectual and physical disabilities. Approximately 80% of participants are under the age of 18 years.



Three Gaits offers several types of activities. Adults and children learn the sport of horseback riding in **therapeutic riding** classes. Occupational or physical therapists work one-on-one with riders in **hippotherapy** sessions, where therapy on the horse helps people improve their abilities in other areas of their life. For some, riding is not a suitable activity but **carriage driving** is an option. For others, **unmounted horsemanship activities** offer a chance to learn about horses and stable management, and practice job skills.

Why horses? Why Three Gaits?

When so many families are struggling to meet basic needs, why are horses and riding important? Parents tell us that children who have been in various therapies all their lives get excited about coming to Three Gaits, while they may resist therapy elsewhere. Parents of challenging adolescents tell us that "horse time" is a valuable motivator for accomplishing schoolwork and complying with behavior plans. A woman with multiple sclerosis tells us that riding was something she loved before MS, and on the back of a horse, she feels like herself despite all the changes MS has made to her body. Families meet other families whose children face similar challenges. Many kinds of support take place during informal conversations at the rail during lessons, whether it's sharing the name of a great new speech therapist or a health club that welcomes teens with Down syndrome.



Health care professionals recognize the value of Three Gaits. Deborah McLeish, MD, UW Health Pediatric Rehabilitation Specialist states, "Children who ride at Three Gaits develop improved head and trunk control, which can lead to improved sitting and standing balance. However, what to me is even more spectacular is how very proud the children are to overcome any fear, and to be able to ride this huge animal. This is especially important when the child is aware they are 'different' from other children because it gives them something to be proud of. Three Gaits is an incredible, valuable, unique service for children with disabilities and I give it my full endorsement!"
