How to Enter

1. Visit Three Gaits website at three-gaits.org to download the entry form and liability release
2. Complete the entry form and liability release
3. Copy of your flu/ rhino vaccine records (given within 6 months of the show date) OR veterinary documentation that the horse cannot be given either vaccine for medical reasons.
4. Make a copy of your negative Coggins test taken within 12 months of the show date.
5. **NEW! IF you showed here in June, and your paperwork is valid, we kept it and you don't have to re-send.**
6. Complete the fillable pdf entry form and liability release; scan your vaccine and coggins, and email to lauren@three-gaits.org. Be sure to save it with a new name for you.
7. **NEW! Pay your fees online** through [Three Gaits "Donate" PayPal button](#) (you don't need have a PayPal account to use ours!)
8. OR Mail your entry form, liability release, vaccine and Coggins, and check for all show fees to:

Review the rules:

- Only complete entries will be scheduled. Entries postmarked past the close date will be subject to availability.
- No stalls are available but we'll have plenty of trailer parking and easy access water supply.
- Based on entries, classes may be combined, divided or cancelled.
- Times will be emailed. Times may be subject to change on show day.
- Results will be emailed and posted on the Three Gaits website.
- Anyone (trainer, helper, spouse) riding a horse on the property must sign a release first. Releases are in show packet and should be mailed with entry. Releases will be available at the show.
- All riders must wear ASTM/SEI approved helmets and boots or shoes with heels while mounted.
- Scratch/Cancellation Policy: Scratches before the closing date will be refunded. Scratches after the closing date will be refunded only if we can fill your times from the waiting list. No entries will be carried over for future shows.

I further agree to hold Three Gaits, Inc., its Board of Directors, Instructors, Therapists, Aides, Volunteers and/or Employees free and harmless from all damages or liability for any injury to person or property arising as a result of the use of facilities, horses and or equipment owned or leased to Three Gaits, Inc., including any injury caused by their negligence.

I am aware of the significant risks of injury that horseback riding and horse-related activities may cause to myself/my son/my daughter/my ward, however I feel that the possible benefits to myself/my son/my daughter/my ward are greater than and out weigh the risk assumed. By signing this agreement I am assuming all risk and do hereby understand that horses are animals, not subject to any guarantee of reliability. Therefore, I agree to release, indemnify and hold harmless Three Gaits, Inc., the Board of Directors, Instructors, Therapists, Aides, Volunteers and/or Employees from all liability they may incur.

In accordance with the Wisconsin Law relating to the limitation of civil liability regarding equine activities: "NOTICE: A person who is engaged for compensation in the rental of equines or equine equipment or tack or in the instruction of a person in the riding or driving of an equine or in being a passenger upon an equine is not liable for the injury or death of a person involved in the equine activities resulting from the inherent risks of equine activities, as defined in section 895.481 (1) (e) of the Wisconsin Statutes."

As specified on the Dressage Schooling Show and Combined Test entry form, an ASTM/SEI approved helmet must be worn at all times while mounted.
